2. Sealed tenders should reach IRC Office: House No. D-42/B, Block #1 K.D.A. Scheme 5, near Ziauddin Hospital Clifton, Karachi on or before **2:30 PM on 01/11/2022** and should be clearly marked “TENDER - Not to be opened before **3:00 PM on 01/11/2022**”
3. Tenders will be opened on the same day i.e., **01/11/2022** at **3:00 PM** in the presence of suppliers or their representatives, who wish to witness the tender opening.
4. In case the public holiday is announced by the Government (Due to security or any other reason) the tender will be opened on the next working day at the same time and venue.
5. The tender committee reserves the right to change the quantities or cancel/reject any or all offers without assigning any reason.
6. Suppliers must not be engaged in any corrupt, fraudulent, collusive or coercive practices including but not limited to applying/ bidding by multiple names/companies.
